



Your Impact by the Dollar

\$1,000 helps fund brain injury awareness campaigns and outreach efforts in communities across Nebraska.

\$1,500 helps cover the cost of providing up to six psychosocial educational meetings for justice-involved youth who have experienced a brain injury.

\$2,000 provides 20 hours of resource facilitation and case management services.

\$3,000 provides continuing professional development for resource facilitators to keep them current on the best practices for working with brain injury.

\$4,000 helps cover the cost of a week's worth of resource facilitation services.

\$6,000 provides up to 30 hours of brain injury education, screening, and consultative services to community service providers across the state of Nebraska.
